**INFORMATION FOR THE SHAREHOLDERS OF  
 THE SEEYOND MULTI ASSET DIVERSIFIED GROWTH FUND (THE “SUB-FUND”)**

Shareholders of the Sub-Fund are hereby informed of the following changes to the prospectus of the SICAV (the “**Prospectus**”).

Capitalised terms used in this notice shall have the meaning given to them in the Prospectus.

As indicated in the notice to the shareholders of the Sub-Fund dated 4 November 2022 , certain changes made to the investment policy of the **Seeyond Multi Asset Diversified Growth Fund** should in principle have been implemented as of 14 December 2022.

However, to ensure proper continuity of the Sub-Fund’s investment strategy and in the best interests of shareholders, it has been determined that such updates should not become applicable.

As a result, we would like to inform you that the following paragraph in the investment strategy has been amended as follows:

<b>Previous version</b>  (should have become applicable as of 14 December 2022)	<b>New version</b>  (continue being applicable as of 14 December 2022)
By combining the two strategies described above (extra financial and financial), between 0% and 50% of the Sub-Fund's net assets may be exposed to global equities, including a maximum of 20% of its net assets exposed to Emerging Market Equities.	By combining the two strategies described above (extra financial and financial), between 0% and 100% of the Sub-Fund's net assets may be exposed to global equities, including a maximum of 50% of its net assets exposed to Emerging Market Equities.  The Sub-Fund's modified duration is between 0 and 12. Up to 40% of the Sub-Fund's net assets may be exposed to emerging market bonds.

The Sub-Fund's modified duration is between 0 and 8. Up to 20% of the Sub-Fund's net assets may be exposed to emerging market bonds.

The new version described above is similar to the version that was in force in the Prospectus dated May 2022 since those investment guidelines were supposed to remain unchanged.

**The changes described above are effective immediately as of 14 December 2022 (the “Effective Date”) and will be reflected in the Prospectus dated 14 December 2022.**
